WHAT TO EXPECT AT THE EXAMINATION

Generally an examination is scheduled to last two to four hours. After the completion of the initial interview, additional information still may be needed. You may submit this information by mail or by scheduling a follow-up appointment. When the examination is completed, you may owe additional tax, be due a refund, or there may be no change to your return.

WHO MAY COME TO THE EXAMINATION

If you filed a joint return, you and/or your spouse may attend. You also may elect to have someone else represent you. If you will not attend with your representative, you must provide a completed Form 2848, *Power of Attorney*, or Form 8821, *Tax Information Authorization*, by the start of the examination. You can get these forms from our office.

6. Financial statements prepared for 12/31/2003.
7. General Ledger and subsidiary ledgers for 12/31/2003.
8. General Journal and subsidiary journals for 12/31/2003.
9. Cash Receipts and Disbursements Journals for 12/31/2003.
10. Accountant's work papers regarding 12/31/2003 year-end: reconciling books to return, adjusting journal entries & closing entries, and bank reconciliations.
11. Worksheets utilized to reconcile the "books" to the return.
12. Bank Statements and cancelled checks from 12/31/2002 thru 12/31/2003.
13. For Cost of Goods Sold please provide year end inventory count sheets. Aging of accounts payables. Copy of Section 263A computation for 12/31/2003 year end.
