Gentlemen:

Your overwhelming attendance and support at the special adjourned session of the Fremont City Council held on Wednesday evening (and Thursday morning!) is very much appreciated. For those of you who could not be there or who left before adjournment, the council took the following actions: (1) rejected approval of the General Plan Amendment that would have permitted residential use of the Santa Fe property by a three to two vote; (2) unanimously approved rezoning of the auto mall property to allow for auto sales use; and (3) authorized the expenditure of \$50,000 to study the unacceptable traffic levels created by combined auto mall, industrial and commercial use on the Santa Fe property.

Additionally, a meeting has been scheduled between Mayor Gus Morrison, City Manager Kent
