Gentlemen:

For the past two weeks, I have been talking with the City and Santa Fe on almost a daily basis. As of Tuesday of this week, I was advised by both the City and Santa Fe that they have essentially come to an agreement which will permit Santa Fe to develop residential housing on their property. Obviously, the Auto Mall is an essential ingredient in that agreement.

As you know, if the residential is approved, the cost of the property is \$5.50 a square foot. I have talked with Kent McClain, Fremont City Manager, and he has agreed that upon my return from vacation on July 18th, he and I will sit down and begin discussions concerning what type of financial assistance the City will provide to the Auto Mall. At the present time, it would appear

that the City is inclined toward discussing the use of redevelopment funds for the installation of infrastructure. If the cost of infrastructure can be deducted from the \$5.50 per foot price and paid for by redevelopment funds there would be a substantial financial benefit to the dealers.

I have discussed these matters with Don Signer and Hank Torian but was unable to call each of you because of the press of business. If you have any questions, you might call Don or Hank and talk with them. I return from vacation on July 18th and intend to schedule meetings with the City and Santa Fe upon my return.
