## First lots purchased for Durham auto mall

FREMONT — Catellus Development Corp. and auto dealers have closed escrow on the first lots to be sold in the planned 88-acre auto mall along Durham Auto Mall Parkway, according to Assistant City Manager Roger Anderman.

Until recently, the parkway was known as Durham Road, but the name was changed to bring in more business to the auto mall.

In a written statement,

Anderman said that dealers Thomas Claridge, Mark Hamilton, Frank Meads, Hank Pierotti and Hank Torian had purchased nine lots and Chrysler Realty Corp. had bought a tenth.

Together, the dealers bought more than 45 acres.

Construction of the mall is scheduled to begin early next year, and at least 20 new auto dealers are expected to open for business in the mall in the fall of 1991.

## Shelter plans killed

FREMONT — A group of residents along Bruce Drive and Middlefield Avenue has defeated an attempt by a neighboring church to become a temporary homeless shelter this winter.

The Rev. John Albright, pastor of the First United Methodist Church at 2950 Washington Blvd., said on Tuesday that his church is withdrawing its application with the city after representatives of the Tri-City Homeless Coalition, which runs the homeless shelter program, could not satisfy the residents'

ors would be on hand at the shelter.

Albright had tried to make his church a participant in the local Winter Relief Program, in which seven Fremont churches already participate. The program is set up so that a church is allowed to offer shelter to up to 30 people for a 30-day period. A church is allowed four 30-day periods during a year.

To become a participant in the program, though, churches must first win approval of the city.

The council intended to hear the appeal early last month, but agreed to delay consideration of the matter until the homeless coalition had a chance to persuade
